### MGH Bylaws Approved Unanimously

Over the last year, MHD has carefully crafted and deliberated over the MGH Bylaws. MHD consulted with community leaders, legal, operational and medical experts, among others, to develop a comprehensive and balanced set of Bylaws that will guide the MGH Corp. Board in successfully managing MGH. The Bylaws were reviewed and commented on during public Board meetings by Board members, community members and members of the MGH staff.

During the January Regular Board meeting, Dr. Kerry Davidson, MGH Chief-of-Staff, represented the MGH physicians and spoke in support of Bylaws that would provide a good foundation of governance for MGH. In addition to Dr. Davidson, more than 20 MGH physicians also attended the meeting and voiced their support. Input was also heard from community members and leaders. Upon hearing the comments from constituents and discussion regarding a proposed amendment, the Tenth Restatement of Bylaws of MGH was approved unanimously by the MHD Board.

The bylaws reflect:

- Community participation in governance MGH will be a true community hospital.
- An experience-based board that will govern MGH operations effectively.

### **MHD CEO Meets with MGH Employees**

# **Sutter Assures Information Technology Continuity During Transition**

#### IT Network to Stay On After Transition

Earlier this year, MHD CEO Lee Domanico met with Dr. Martin Brotman, Sutter Regional President (West Bay region) to discuss IT continuity during the transition. Though MHD has contracted with Affiliated Computer Services, Inc. (ACS) to provide IT services, and anticipates the new system will go live on June 29th, Dr. Brotman graciously offered to provide a second layer of assurance that the transition would not cause any interruption in IT-related operations at MGH. Dr. Brotman offered to let the existing Sutter system continue running if needed at transition. Dr. Brotman assured MHD that Sutter's IT system would stay in place after the transition to ensure IT continuity. Dr. Brotman offered his assurances that Sutter would work with MHD and ACS to ensure a smooth transition between IT systems.
