A. Planning the Next Webinar

The next Community Health Webinar will be on "Health Effects of Climate Change." Ms. Taylor has been in touch with Chris Tubbs, Southern Marin Fire Chief, who has expressed interest in being a panelist. Ms. Rienks is contacting officials from Marin County HHS, including Dr. Matt Willis and Dr. Lisa Santora. Dr. Klein suggested contacting a climatologist, possibly from UCSF.

Ms. Rienks noted that she viewed a UCSF webinar on "Climate Change, Health Equity, and Maternal, Child and Adolescent Health." That event included Dr. Linda Rudolph, Director of Center for Climate Change and Health at Public Health Institute. Ms. Rienks will contact her.
